## **Additional Fees (If Applicable)**

- Custodial Fee (Required for events over 4 hours or after 8:00 PM): \$30/hour
- Security (if required by administration): \$35/hour
- Damage Deposit (Refundable):
  - Dome: \$500
  - High School Gym: \$300
- Equipment Use (sound system, scoreboard, tables, etc.): \$50 flat fee
- Cleaning Fee (if excessive cleaning required): deducted from deposit

## TERMS AND CONDITIONS

1. **Approval Required**  
All rentals are subject to approval by the Superintendent or designee.
2. **Priority of Use**  
School-sponsored activities always take precedence. Approved rentals may be rescheduled if necessary.
3. **Supervision**  
Renter must provide adequate adult supervision at all times.
4. **Insurance**  
Proof of liability insurance may be required for certain events. Fowler USD 225 may require the district to be named as additionally insured.
5. **Prohibited Activities**
  - No alcohol, tobacco, vaping, or illegal substances.

- No weapons permitted.
- No open flames without prior written approval.

**6. Care of Facility**

Renter agrees to return facility to original condition. Damage beyond normal wear will be billed to renter.

**7. Cancellations**

- 7+ days prior: Full refund minus \$50 processing fee
- Less than 7 days: Deposit forfeited

**8. Indemnification**

Renter agrees to hold harmless and indemnify Fowler USD 225, its Board of Education, employees, and agents from any liability arising from use of the facility.

**9. Emergency Authority**

District administration reserves the right to terminate event if safety concerns arise.
