Membership Cancellation: This membership may be cancelled by providing written notice to Fowler USD 225. Upon cancellation, Members must return all issued access cards.

Membership Rules and Participation

The Member hereby agrees to abide by all posted safety guidelines and regulations while using Fowler USD 225 facilities and equipment.

The Member agrees to dress and conduct themselves in a manner deemed appropriate for a fitness facility.

The member agrees to leave the facility in the same condition or better than it was found.

The Member shall not consume alcoholic beverages, drugs or tobacco products on Fowler USD 225 property.

Membership grants 24/7 access to the Wellness Center / Weight Room only. The High School Gym is available during specific posted times. Membership does not grant access to any other district facility.

Winter Hours (HS Gym) 6:00am-8:00am and 8:00pm to 10:00pm

Summer Hours (HS Gym) 6:00am-8:00am and 5:00pm to 10:00pm

Payment is due on the 5th day of each month. There is no grace period.

No one under the age of 16 years old is allowed in the facilities without an adult (18 years or older).

Waiver must be signed by all family members using the facility.

Fowler USD 225 reserves the right to restrict or remove members' access for violations of rules or damages to the facilities or equipment.
